

CITY OF WINTERS, TEXAS 310 S. MAIN ST. WINTERS, TX COUNCIL CHAMBERS SPECIAL MEETING MINUTES

April 20, 2024, 1:00 p.m.

Call meeting to order. Mayor Chris Bahlman called the meeting to order at 1:02 p.m. and a quorum was established. In attendance were Bahlman, Mayor Pro-Tem Jimmy Butler, Alderman Mike Neal, Alderman Wesley Hagle, Alderwoman Ida Rodriguez, Alderwoman Ursula Estrada, and City Administrator Nate Smith. Community Member Mark Burkhart was also in attendance.

Agenda Item 1. Community Input. None.

Agenda Item 2. Executive Session, Texas Government Code 551.087, Economic Development K & M Tire, Tax Abatement; Texas Government Code 551.072, Real Property, 500 S. Main St. Winters, TX. The Council adjourned into executive session at 1:03 p.m.

Agenda Item 3. Reconvene in Open Session. The Council reconvened in open session at 2:09 p.m.

Agenda Item 4. Consider and take possible action on items discussed in Executive Session. Alderwoman Ida Rodriguez mage a motion to appoint the firm of Messer Fort, PLLC, as outside counsel for Tax Abatement Services, second by Mayor Pro-Tem Jimmy Butler. All in favor, motion carried 5-0.

- **a.** Vision, Mission, Values City Administrator Smith gave the council a presentation of the staff's work on Vision, Mission, and Values.

- d. Zoning Code City Administrator Smith then asked the council if they were interested in revising portions of the zoning code that are outdated. Smith will start working with the Planning and Zoning Committee first before taking any recommendations back to the council.
- e. Reorganization City Administrator Smith then led discussion on the council in terms of reorganization and redistribution of areas of responsibility.
